of responsibility and provide feedback.

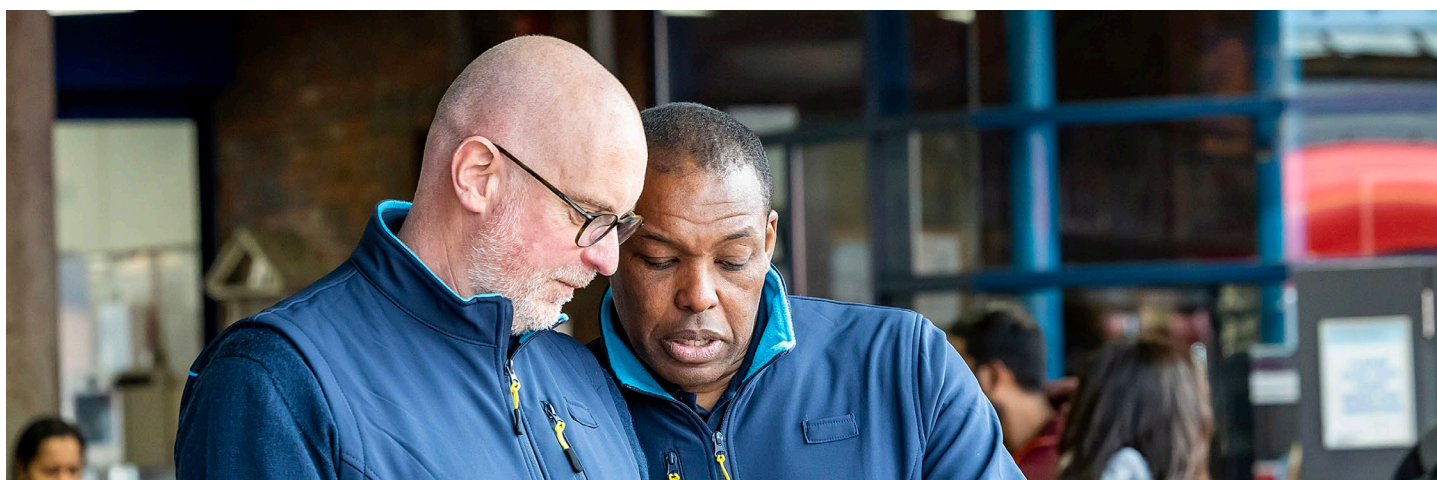
4. Review and amend plans of work for own area of responsibility and communicate changes.
